1. **The completed Nomination Form and all supporting letters must be received by the Council on or before December 11, 2010.**
2. Please submit the nomination packet, in PDF form, to: [tstephens@okscouts.org](mailto:tstephens@okscouts.org).
3. A cover letter and three (3) letters of support may be submitted with the nomination form.
4. Give the full name and titles (if any) of the nominee exactly as you want them to appear on the certificate.
5. Furnish as much information as possible for each section.
6. Long-established policy limits the award of the Silver Beaver to adults 21 and older who are registered with the Boy Scouts of America as volunteer Scouters. Explorer leaders are eligible to be awarded the William H. Spurgeon III Award.
7. Nominations will not be considered for current or former professional Scouters within five (5) years of their leaving employment with the BSA. Other council employees (part time or full time) are eligible to receive the Silver Beaver Award based on their volunteer service, not employed service.
8. Nominations cannot be considered for posthumous awards.

## RULES AND REGULATIONS of the BOY SCOUTS OF AMERICA

Article X, Section 6, Clause 3  
Silver Beaver Award

The Boy Scouts of America, acting through the National Court of Honor, may award the Silver Beaver for distinguished service to youth upon the following basis and procedure:

- a) Each local council may process their own annual allotment of Silver Beaver awards and shall send a list of Silver Beaver recipients presented each calendar year to the National Court of Honor no later than January 31 of the following year.
- b) The award is made for noteworthy service of exceptional character to youth by registered Scouters, Cub Scouters, Varsity Scouters, and Venturing leaders within the territory under the jurisdiction of a local council.
- c) As evidence of the award there shall be presented: a suitable certificate, duly authenticated by the Boy Scouts of America, pursuant to the action of the National Court of Honor; and a miniature Silver Beaver suspended by a blue, white, and blue ribbon to be worn around the neck.
- d) It shall be a general policy that no public announcements shall be made by the local council in advance of action by the National Court of Honor with reference to names presented for consideration.
- e) These awards shall be made to the recipients by the local council concerned in connection with its annual meeting or other public location.
- f) Each duly chartered local council shall be entitled to one nomination. Councils having more than 60 units shall be entitled to further nominations on the basis of one for each additional 60 units or fraction thereof in their territory, as of December 31 preceding the nomination, according to the records of the national office.
- g) Councils not using their full allotment in any year may accumulate the unused portion for use in any subsequent year.
- h) In extraordinary cases, the Silver Beaver Award may be made by the National Court of Honor to a Scouter upon the recommendation of the duly constituted Scouting authorities having supervision of one or more units of the Boy Scouts of America, located outside of the United States and not under the jurisdiction of a local council.

## TIPS FOR A SUCCESSFUL SILVER BEAVER NOMINATION

- Start as soon as possible. It takes longer than you think to put together a nomination packet.
- Read the Silver Beaver Award Nomination Form. It will give you an overview regarding the qualifications that the Selection Committee will be looking for and what to emphasize. Notice that there are three areas of qualifications: (1) Service to Scouting, (2) Service to Youth Outside of Scouting, and (3) Service to the Community. ***It is very important to have information in each area.***
- Fully complete the Nomination Form. If you do not fully complete your candidate's Nomination Form, s/he may not be selected when compared to other qualified candidates. Help your candidate's possible selection by being as thorough as possible.
- Contact your District professional to get a copy of your nominee's profile from ScoutNet, which includes the Scouter's positions, training records and awards recorded with the Council. This will assist you in completing the Record of Service section on the Nomination Form.
- As you summarize the candidate's three areas of qualifications, the Selection Committee will recognize the nature and value of a candidate's noteworthy service to youth may take the form of a single plan or actions which contributed to the lives of large numbers of youth or that the service may be given to small groups over an extended period of time.
- Contact the candidate's spouse, parents, and/or adult children. They may be able to provide you with a resume that will give you a lot of the information you need. Ask for information about the Scouter's activities outside of Scouting and possible contacts with those groups. Requesting a letter from one of these contacts is acceptable and desirable.
- As you contact people to write letters of recommendation, be sure to remind them that the nomination should remain confidential. Your candidate should not know s/he has been nominated. Letters should be addressed to Silver Beaver Selection Committee; Indian Nations Council. If the person is not a Scouter or is not familiar with the award, be prepared to give them an idea of what you are looking for in a letter. If you send a request by mail or e-mail, you may want to follow-up in a few days. Arrange to have the letters sent or e-mailed to you. You will need to turn in the completed packet to the Council office by the designated deadline. This will give the Council office time to review the packet and determine if any additional information is needed.
- **NEW FOR 2020! There is a maximum of three (3) letters permitted in the packet in addition to the nominator's cover letter. Be sure to contact non-Scouters for letters.** These may include someone from the nominee's church, someone who has been a fellow coach with the nominee, a parent whose children has been coached or taught by the nominee, fellow "lodge" members (Elks, American Legion, etc.), etc. Contact people who have known the nominee on different levels of Scouting involvement (Cub Scouting, Scouts BSA, Venturing, District, Order of the Arrow, High Adventure, etc.). Having a variety of letters is preferable to letters from the nominee's unit only. Be sure to highlight various/all levels of the nominee's involvement in the Scouting program.
- Your nominating letter should indicate how you know the candidate and why you are nominating him/her. List the qualifications you see in your candidate.
- You will be notified of the Selection Committee's decision regardless of the outcome. If your candidate is selected, s/he will be notified before you and provided with information about the Recognition Dinner.
- If your candidate was not selected, do not be too disappointed. First, there are many qualified people out there who are nominated each year. Second, it is common for a candidate to be nominated more than one time. **NEW FOR 2020 -** Nomination packets will be held over for one year only and automatically re-submitted in the next year.
